

Shipping instruction for inbound deliveries to BARTEC based on the Incoterms EXW/FCA

This shipping instruction (in accordance with § 3 No. 5 of the General Terms and Conditions of Purchase and Ordering of the BARTEC Group) is a supplement to the contractual agreements between suppliers and BARTEC and applies to all parcel and general cargo shipments as well as partial and full loads if the following addressees or locations are affected:

- BARTEC GMBH location in **Bad Mergentheim**
- BARTEC VERTRIEB DEUTSCHLAND GMBH location in **Bad Mergentheim**
- BARTEC BENKE GMBH location in Gotteszell
- BARTEC GMBH location in Leipzig
- BARTEC Benke GmbH location in Reinbek

and the respective company is the freight payer (agreed delivery terms EXW and FCA).

Deliveries from BARTEC shall always be made in accordance with this shipping instruction.

Deliveries shall always be made by using the Standard / Economy Service. The commissioning of express shipments must be authorised in writing by BARTEC prior to commissioning. Otherwise, the additional express costs shall not be borne.

Partial and full loads must be agreed with BARTEC.

On the basis of the specifications in this shipping instruction, the supplier must contact the forwarding agent(s) specified by BARTEC independently and coordinate the operational processing with the forwarding agent(s) in terms of the transportation order.

When placing the transport order, please note that the correct BARTEC company must be specified as the freight payer.

Required data for notification of shipments to the forwarders specified by BARTEC:

- Weights, number, type and dimensions of the packages
- Complete dangerous goods information (in case of dangerous goods)
- Loading times of the shipper
- Delivery terms
- respective BARTEC order number
- BARTEC customer number (depending on the consignee)
- Proper freight and accompanying documents must be handed over to the forwarding agent and pallets must be marked with "DO NOT OVERLOAD".

Notification of shipments

Fedex, Schenker and Kühne + Nagel provide free shipping software that can be used in order to print out shipping labels as well as to notify pick-up (see table).

Transport insurance

BARTEC is a waiver customer/prohibited customer due to its own transport insurance. BARTEC therefore does not have to pay transport insurance fees.
